I/We the undersigned, agree that the Host Club has the right to refuse my entry for causes which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry and the holding of the event and the opportunity to have the dog participate or be judged, I/We agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, the Agility Association of Canada, sponsors of the event, owners of the premises upon which the event is being held and their employees, harmless from any claims for loss or injury which may be alleged to have been caused directly or indirectly to any persons or thing by the act of this dog(s) while in or upon the event premises or grounds or near entrances thereto, and I/We further agree to hold the aforementioned parties harmless from any claim for loss of this dog(s) by disappearance, theft, death or otherwise and from any claim for damage or injury to the dog(s), whether such loss, disappearance, theft or otherwise be caused by or alleged to be caused by negligence of any other person, or any other cause or causes. I/We hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because bodily injuries, including death at any time resulting thereof, sustained by any person or persons, including myself/ourselves or on account of damage to property, arising out of or in consequence of my/our participation in this event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other parties.

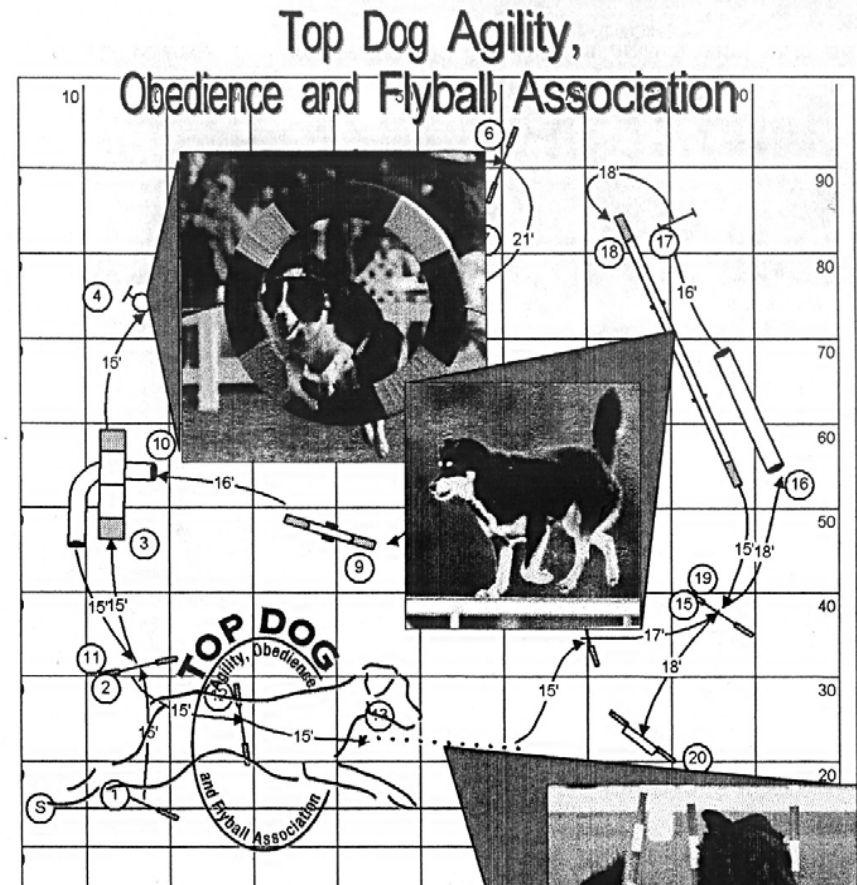
